## IUHF Subscription Scale

The International Union for Housing Finance (IUHF) operates a subscription scale, as set out below, which requires members to pay varying annual subscription fees based upon the type and size (in terms of assets) of their organisation.

### Lenders

If your organisation is a lender, its annual IUHF subscription fee can be determined by placing its total assets in the correct bracket of the following scale:

Assets exceeding €188 but not exceeding €438	€460

Individual or not-for-profit organisation associated with or interested in the furthering of the objectives of the IUHF or associated in a professional, educational, social or benevolent activity	€255
Governmental or quasi-governmental organisations that perform regulatory, central banking or insuring functions for institutions in any country	€460
Corporations whose business is local or regional in its scope	€460
Corporations whose business is national in its scope	€895
Corporations whose business is international in its scope	€1,750

## Important Notes

IUHF subscription fees cover membership for the calendar year. If a new member is admitted after the 1<sup>st</sup> of September in the calendar year, only half of the annual subscription fee will be charged.

No member shall be entitled to any of the rights of membership while its subscription for the calendar year in progress remains unpaid.

Membership of the IUHF will lapse automatically if the annual subscription fee of a member remains unpaid by the 31<sup>st</sup> of June of the year following the calendar year in which they are due. The IUHF Executive Committee, at its discretion, may waive the condition for any period.

The annual subscription fees of organisations that have only part of their assets in home financing shall be calculated by reference to the proportion of their total assets attributable to home financing.
